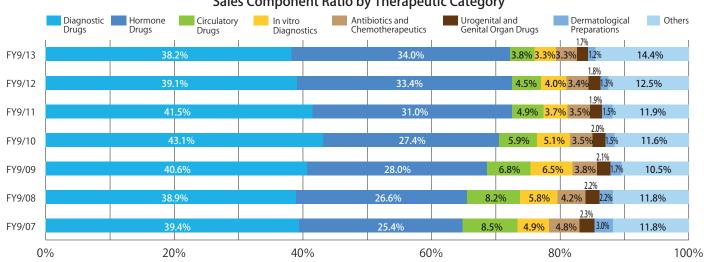

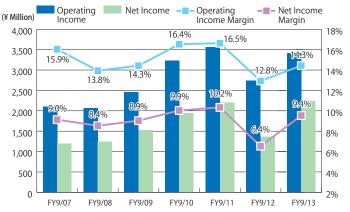
R&D Expenses Ratio

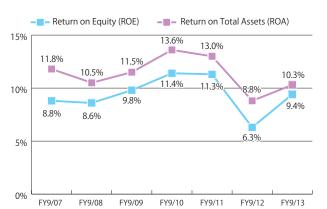


Fixed Ratio
